90° brass connections for refrigeration and air-conditioning systems comply to DIN 8912 standard, SAE J513 standard, U.S. Military Standards MS-35867 through MS35873 inclusive, MS-35919, MS-24815 and MS-16993.

Product features

- manufactured from brass forgings (*compliant to standards EN 12420 and EN 12165*) or drawn brass rod (*compliant to standard EN 12164*) which eliminate the possibility of leakage due to porosity in the material
- accurately machined and fully protected against damage during shipping, handling and storage to assure tight leakproof joints
- smooth interior finish provides unrestricted flow and reduced pressure drop
- smooth sealing surfaces finish and tight tollerances to eliminate the risk of leakage
- risk category as per *Art. 4 Par. 3 of Directive PED 2014/68/EU*
- suitable for HCFC, HFC and R744 (CO₂) refrigerants. *Not suitable for ammonia*

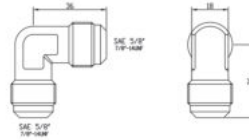
